The Dickinson City Council met in a duly called and announced **SPECIAL WORKSHOP MEETING** on **TUESDAY, AUGUST 10, 2010**. The meeting was held in the City Council Chambers located at 4403 Highway 3, Dickinson, Galveston County, Texas, and was held for the purpose of considering the following items:

**ITEM 1.) CALL TO ORDER AND CERTIFICATION OF A QUORUM**

**ITEM 2.) BRIEFING AND DISCUSSION CONCERNING:** Presentation by HDR/Claunch & Miller regarding the Status of the Development of the Comprehensive Drainage Study.

Jimmy Thompson and Rich Gallegos of HDR/Claunch and Miller gave a power point presentation of the recommendations for the 19 "hot spot" drainage problem areas previously identified by the City Council at an earlier meeting with City Council. They discussed each hot spot, the recommended improvements needed and estimated costs. They also explained the methodology used for ranking the hot spots. After some discussion, Council took no action. The City Administrator noted that the complete Comprehensive Drainage Study would be presented at a later date.

Mayor Pro Tem Wilson made a motion to adjourn the meeting at 7:01 p.m. Councilman King seconded the motion.


