The parade in part, will help to fund our lighting efforts of National Oak Park, Historic Depot Centre, and what will soon be referred to as Alvin's Holiday Square as we add more lights in this area every season. We will be honored if you accept our invitation. In order to defray our expenses for additional lights in the park we are requesting a fee of per entry (per auto).

The parade line-up will begin at 4:30 pm on Saturday, December 1st, the Stantons parking lot off of Taylor and Hood. There, you will be given a numbered place card and be directed to your spot in the parade. The parade will begin at 5:30 pm.

Parade Guidelines

- 1. All entries are encouraged to decorate with the Home for the Holiday theme by using Christmas lights to showcase your business/etc. floats.
- 2. Throwing of candy or promotional toy items is permitted. Please use extreme care and throw close to the curb not in the street to keep kids in a safe from parade traffic area.
- 3. The line-up will numbered as applications come in with the exception of city and county officials and School marching bands .
- 4. Entries must have representative's signatures.
- 5. All entries are subject to prior approval by the Parade Committee.
- 6. All drivers of equipment or vehicles shall be experienced and licensed.

Hold Harmless: Participating entrants agree to indemnify and hold harmless the City of Alvin, its board, staff, officers, agents, and employees from any and all claims, causes and suits occurring or resulting from any damage, injury or loss to any person or persons, including, but not limited to loss of property, goods, wares or merchandise, caused by, arising out of, or in any way connected with the exercise by the entrant of the privileges herein granted.

Liability: The City of Alvin, its board and its staff will not be responsible for losses of any kind whether by fire, theft, physical violence, elements of nature, or any other cause however originating.

Safety: Participants are responsible for their own merchandise and equipment and the conduct of their entry and are liable for any injury or accident caused by their entry and its protection and insurance. **Request:** There shall be one adult per five children on the floats. All children that ride on a float must remain on the float or in the vehicle for the duration of the parade.

Alcohol: No consumption of alcohol or any controlled substance in the parade area, including, but not limited to, pre-parade and post-parade areas.
