Payment Methods

Memberships may be purchased month- to -month or annually. For the annual/seasonal membership, payment will be a one-time fee that provides access to the facility of choice. This membership expires one year/seasonally from date of purchase. Memberships may also be purchased and renewed monthly. Payment will need to be made once a month upon your monthly expiration date. *Coming soon:* EFT (electronic funds transfer)! This will be the best deal and is the simplest and easiest way to pay. Once a month the fee is electronically transferred from your checking account, MasterCard, Visa, or Discover Card. No long term commitment and no contracts to sign. You may cancel at any time by notifying the front desk staff in writing by a specified date, prior to the month you want your membership to end.

Refund Policy

Monthly Memberships – are not refundable or transferable.

Annual Memberships – Annual memberships are not refundable but may be stopped per the request of the membership owner at any time. To end your membership, please notify the front desk staff, in writing by the 15<sup>th</sup> of the month prior to the month you want your membership to end.

A refund request/stop EFT payment form must be completed at the Customer Relations Desk for all refunds.

**Note(s):**

- **Individual:** applies to one (1) person in household. Membership in non-transferable.
- **Couple:** Membership for two people directly living in same household. Must be able to show proof of residency at same address. Membership in non-transferable.
- **Family:** A family is considered as all members living at the same household. Individuals must be able to show proof of permanent residency at that address. Membership is non-transferable
- **Tennis/Racquetball "Add-ons":** Ability to phone in your reservations 72 hours in advance. Membership is non-transferable.
- **Tennis Annual:** Separate from memberships. Does not allow entrance to West University Place Recreation Center or Colonial Park Pool. Membership provides ability to phone in your reservations 72 hours in advance.
- **Adult** – An adult is defined as an individual 18 years of age or older.
- **Senior** – A senior is defined as 65 and older and must be a resident of West University Place. Resident seniors will receive a 100% discount on all memberships
- **Refunds** will not be given on any passes purchased.

We understand that the word "claims" includes all of the following that have arisen, or may arise later, in connection with the activity, whether known or unknown: claims, demands, causes of action, losses, costs, liabilities and related expenses, including those involving the joint or sole negligence of the City, those involving the negligence of ourselves or others and those which arise otherwise. 4. Limitation of Liability.
